## 3. Toledo Department of Public Utilities

- Capital Improvement Plan update Jake Goetz
- Continuous Capital Improvement Plan 2023 Activities presented by Jake Goetz
  - Minor dollar amount changes
  - ➤ Active projects site improvement project moved from design to construction section bid was higher than anticipated (\$1 million)
  - ➤ Basin 1 4 project issuing substantial completion final completion of significant deficiency cited by OEPA
  - Monitoring/updating estimates
- Continuous CIP
- Loan/grant application status
- Raw Water main

- **➤** 2029 completion
- ➤ RFP will be advertised 4/28/23
- Updated information due to group due to error regarding Raw Water main
- Water Distribution System Updates presented by Todd Saums
  - ➤ Approaching 39,000 meters changed out, some resistance
  - ➤ Timing? Our consultant, Deloitte, is working to make this a seamless project
  - ➤ Joint project with Washington Local Schools to install water tower
  - ➤ Received another \$2 million grant from Ohio EPA for lead services
  - Numerous grant applications going on at this time
  - ➤ Went to City Council to request additional money for valve repair
  - New database will identify every curb box location in city
  - City of Toledo is not affiliated with water/gas service contract through Columbia Gas
  - ➤ A small percentage of customers are complaining bills are going up once new meters are installed; new meters are more precise

## 4. Rate Subcommittee Report

- In 2024 we must have rates in place
  - ➤ Plan is to introduce legislation later this year to continue and complete the elimination of rate surcharges
  - > Raw water main construction
  - ➤ Alternate water source
  - Closing on farmland in Oregon where we plan to build reservoir to complete alternate water source
  - Asked Ohio EPA for extension on alternate water source; granted additional
     15 years plan to push forward much quicker
  - Plan to add cost of design for alternate water source to next round of rate increases
  - ➤ 4-year rate increase recognized; possible 5 year increase? Not required
  - Several rate scenarios presented by Robert Kasischke
  - Request for revenue breakdown will be in monthly financial report

## 5. Communities Status Reports

- Northwest Water & Sewer District
  - ➤ 2 projects Tracy Rd. waterline replacement (thank you to Toledo staff for assistance) and opening up 2<sup>nd</sup> altitude valve
- Village of Whitehouse
  - Moving forward with another water tower
- Lucas County
  - Installing new underground storage tanks
- Fulton County
  - > Delta will be making connection soon
- Perrysburg
  - Question regarding whether FAA lighting is required?
  - ➤ In middle of switching over to AMI
  - Delays in several projects costs and availability of materials
