- 5. Communities Status Reports-\*Due to technical issues the following communities reports were not recorded.
  - Fulton County\*
  - Monroe County\*
  - Northwest Water & Sewer District\*
  - Lucas County\*
  - Perrysburg
    - Wrapped up next to expressway, site cleaned up
    - > First AMI units last week
    - ➤ Wrapping up 4,800 ft. of 4"cast iron main to be replaced with 8"
  - Sylvania
    - ➤ Started conversation regarding 2025 crossing replacement
    - Pump station  $-\frac{1}{2}$  dozen things to be taken care of
    - Replacing mobile telemetry units. AMI system in place for 15-20 years, replacing as batteries wear out, ordered but not yet received, possibly in January
  - Toledo
    - Expect to spend \$45 million this year in capital improvements. Three (3) projects in design:
      - ♦ Chemical feed line to intake crib (12 years)
      - ♦ Plan and drain site improvement
      - ♦ Bulk alum feed improvements negotiating with Ohio EPA
    - ➤ High service and filtered water conduits completed
    - Filter and Pipe Gallery improvements well ahead of schedule operation to start this month
    - ➤ High Service pumping station
      - ♦ Pump 4 returned yesterday
      - ♦ Pump 5 will be returned today
    - Basin 1-4 upgrades should be operational by March or April 2023
    - Ozone in regular service since March
      - ♦ THMs down 40%
    - Lab improvements refurbished
    - ➤ Elevated storage tank projects all site locations set; working on details with Washington Local
    - AMI project going well, sending mailers out to inform customers they will be receiving new meter
    - ➤ Lead line replacement contractor doing private side with ARPA funds
    - Estimation of lead line replacements to be done? 3,000
    - Aggressively seeking to secure funding from Ohio EPA
    - ➤ Toledo meter replacement what order? Map on webpage
