- Group met re: replacement/repair of raw water main on 11/17/22
- Jones & Henry report discussed
 - Motion to recommend (Monroe) new 78" steel pipe - \$175 million
 - ♦ *Motion seconded*
 - ♦ No objections
 - ♦ *Motion approved*

 - Looking at adding elevated storage tower
- Lucas County
 - ➢ Water replacement project issues − OPWC?

 - Small upcoming projects
- Northwest Water & Sewer District
 - Took bids on 16" water main
- Fulton County
 - Delta opened bids
 - Delta Village Administrator recommending for all of Delta to receive water from Toledo – not yet approved
 - Swanton doing work on water tower, no dates yet re: purchasing water
- Perrysburg
 - Triannual survey with EPA happening
 - Planning water main replacements
 - Progressing with AMI installation
 - Updates to contingency plan
